- a) Shows after 1<sup>st</sup> March 2017 – 31<sup>st</sup> July 2017 will award qualifications for the 2018 P(UK) Winter Classic, Equifest 2017 and BSPA 2017. Shows after 1<sup>st</sup> August 2017 – 28<sup>th</sup> February 2018 will award qualifiers for the P(UK) Winter Classic 2018, Equifest 2018 & BSPA 2018.
- b) Affiliation fee includes free insertion into Ponies Association (UK) Show Directory and regular updates on Ponies Association (UK) website – www.poniesuk.org
- c) That the rules of Ponies Association (UK) as published in the Associations Current Rule Book will be observed and applied in full.
- d) That the proof schedule will be forwarded to the Ponies Association (UK) office at least **8 weeks** before the scheduled event for approval and the allocation of an affiliation number which must be printed on the front cover of the final schedule. All amendments requested must be incorporated and approved before the final schedule is printed.
- e) That qualifying classes are scheduled by your Committee for 2017 before applying to Ponies Association (UK).
- f) Qualification Tickets must be awarded to 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> placed horses/ponies in every P(UK) qualifying class.
- g) That Judges and wording used in the schedule to describe qualifying classes are correct according to the Ponies Association (UK) current Rule Book.
- h) That the promoting body will comply with all appropriate regulations relating to health and safety requirements, provisions of medical services and supplies and fire precautions and that it will be the sole responsibility of the promoting body to ascertain from the appropriate authorities the extent and nature of these obligations. That the promoting body will comply with the general duties under the Health and Safety at Work Act 1974 and ensure the health and safety of all persons, whether they are organisers, officials, participants or members of the public or any other person who may be affected whilst at the event.
- i) Individual members and organisers of affiliated shows **MUST HAVE** Public Liability Insurance for an adequate limit of indemnity and valid for the day/s of the show/s. Ponies Association (UK) has their own cover to protect their liability, but this does not extend to cover the negligence of individual members or organisers of Affiliated Shows.
